- **The only one municipality directly under the central government in Midwest China**

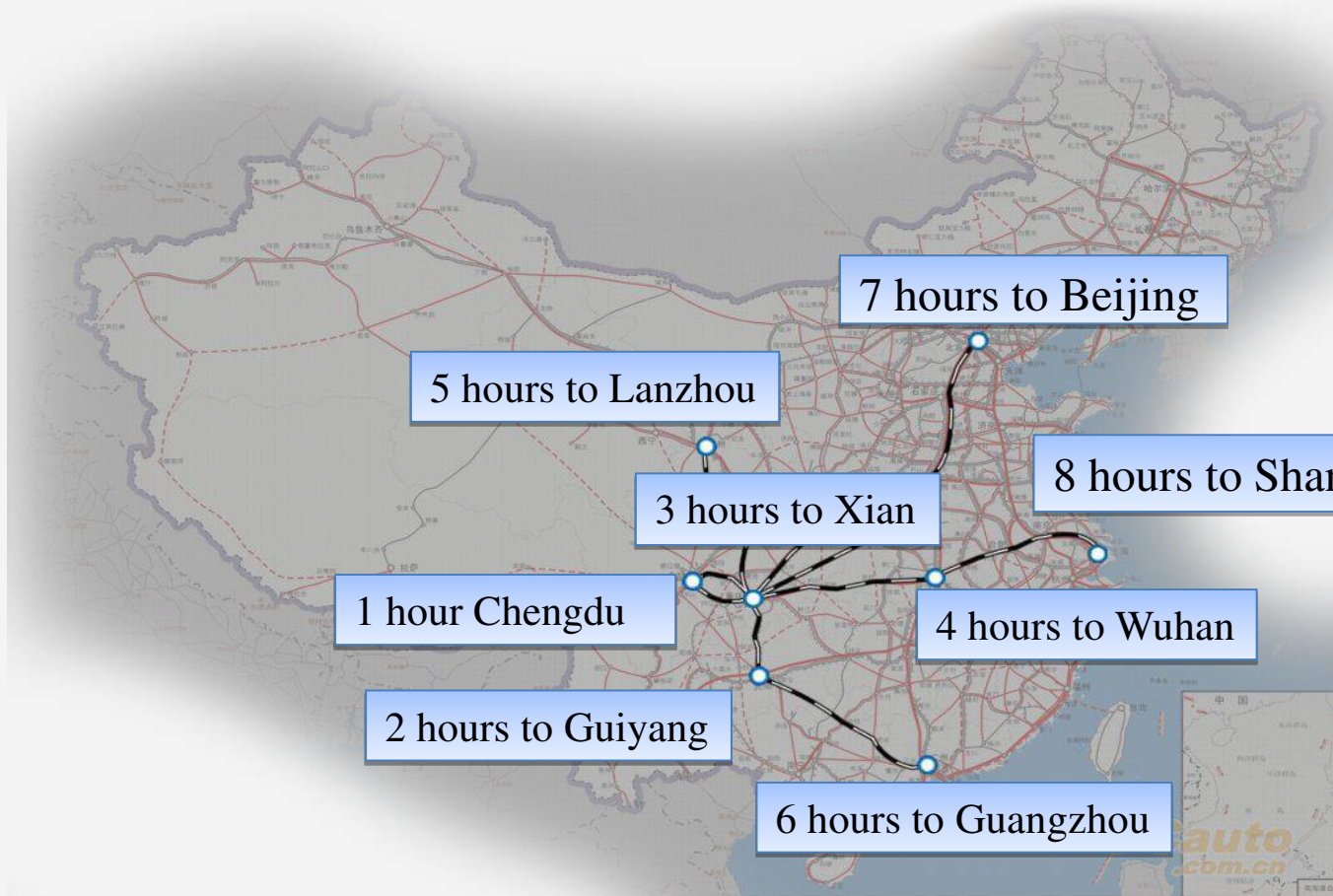

投资优惠政策（Preferential Policies for Foreign Investment）

1. 《外商投资产业指导目录》或《中西部地区外商投资优势产业目录》鼓励类项目，到2020年减按15%的税率征收企业所得税。The Enterprise Income Tax will be levied at a reduced tax rate of 15% until 2020.
2. 设有产业引导股权投资基金、重庆市战略性新兴产业股权投资基金等多个产业引导基金，总规模超过1300亿元。Industry Guiding Equity Fund and Strategic Emerging Industries Equity Fund.
3. 根据项目投资额度、产品品种、税收等情况，可与相关园区进一步协商政策支持。Individualized preferential policies shall be available through further negotiation with potential industrial parks.
4. 根据“黄金十条”或《重庆市人民政府关于做好稳外贸稳外资稳外经有关工作的通知》等政策文件对外资企业或项目进行奖励。According to government policy such as “golden 10 article” or other notice to support foreign investment.
